

EASTER IN FAIR PARK  
EXHIBIT LEASE AGREEMENT  
RED RIVER VALLEY FAIR ASSOCIATION

We, the undersigned, herein after called Exhibitor, hereby agree to lease the following space(s) in the Fair Association Easter In Fair Park herein after called the Event and/or Management, under the following conditions:

Saturday, March 22, 2008

9:00 AM - 4:00 PM

Set up time for all exhibitors is Friday March 21, from 9:00 AM until 7:00 PM and Saturday March 22, from 7:00 AM - 8:30 AM. All exhibitors will advise management upon their arrival for space assignment. The actual occupation of the space is of the essence. All leases space must be in place and ready thirty (30) minutes prior to opening. In the event Exhibitor shall not occupy said space two (2) hours prior to official opening of the show, then and in such event the management is expressly authorized to occupy or cause said space to be occupied in such manner as it may deem best for the interest of such show without rebate or allowance whatsoever to Exhibitor and without in any way releasing the exhibitor from liability hereunder. The exhibitor agrees to pay all legal fees and cost in any action arising from or during enforcement of this contract.

All exhibitors displays will be removed from the Fairgrounds no later than 7:00 PM Saturday, March 22, 2008, or Exhibitor will be liable for any expenses in order to comply with this contract condition. Exhibitor agrees to hold management harmless from all and any liability incurred directly or indirectly by agreement. Further, Management shall not be liable to Exhibitor for any damages whatsoever, or loss of any kind to her/his exhibit or product. After hour security will be provided by management on Friday following close of exhibit buildings.

A booth or booth number of location of said booth may be changed at discretion of event manager(s) for the benefit of the majority of exhibitors or the event itself.

Event management will furnish the booth space:

\*Arts & Crafts will have 8x10 space with one six foot table and two chairs, and power for the electrical needs to Exhibitor (110 only). Exhibitor must make request for electrical need, one (1) outlet each space, at time of agreement so Management can locate space in proper area.

Exhibitor and their employee(s) will conduct themselves in a manner lending dignity to event. Event manager may at his discretion, eject any Exhibitor or employee from premises and no refund will be applicable to Exhibitor under such conditions.

Cancellation of this contract must be in writing fourteen (14) days prior to event; and Exhibitor waves any refund applied to space rental agreement. The set up fee is required at time agreement is signed.

It is agreed that no agreement between Exhibitor and event or their representatives is binding unless attached hereto; that no oral promise of any type are a part of this agreement.

Management will advise of parking area set aside for Exhibitor or their employee(s) after set up is complete.

Management will provide all advertising for the event.
